Sales Agreement: Non-Breeding Companion

SunoJo Kennels is dedicated to the preservation of the Shiba Inu breed. This Agreement is designed to assure the well being of this particular animal.

This pup will be sold on a seventy-two (72) hour trial period. During this time, it is recommended that a reputable veterinarian examine the dog. If the dog is found unsuitable for any reason, the full purchase price will be refunded if the pup is returned to the Breeder with a properly completed certificate of non-health from a reputable veterinarian. Cost of returning the dog to the Breeder will be borne by the Buyer.

Warranty

This dog is being purchased as a pet and the Buyer will not be entitled to any compensation should it acquire any disqualifying show faults. The Breeder will warrant said dog for any hereditary defect which may develop that would render the dog unsuitable as a companion animal until said dog reaches two (2) years of age. If the Breeder and a reputable veterinarian of the Breeder's choice determine that the dog is not suitable as a companion animal, the dog will be returned to the Breeder and replaced. If a replacement is not available within twelve (12) months, the full purchase price will be refunded. However, no dog that has been improperly trained or socialized, or develops a health problem due to inadequate care, poor conditioning, or injury will be replaced or refunded.

The Breeder warrants that this pup will be inoculated with first shots, dewormed and registered with The Canadian Kennel Club.

Non-Breeding

This dog is being purchased as a companion and is not to be bred. The Buyer agrees to take the aforesaid dog to a reputable veterinarian to be spayed or neutered between nine (9) and twelve (12) months of age. A copy of the spay/neuter certificate will be forwarded to the Breeder.

Once the Breeder receives a copy of the spay/neuter certificate, the Breeder will transfer Canadian Kennel Club registration to the Buyer.

Care

The Breeder has first right of refusal should the Buyer not be able to keep the dog. Under no circumstances will this dog be taken to an animal shelter, rescue society, pound, pet store or broker to be resold. If the dog is returned to the Breeder, cost of shipping is the responsibility of the Buyer.

The Buyer agrees to take proper safeguards for the care and safety of the animal sold herein, including but not limited to a fenced yard, solid housing, adequate water and feeding, exercise, training, regular and emergency veterinary care. Tying/staking out the dog while unattended, leaving the dog in a car or exposed to the elements, allowing the dog to run at large, or failing to provide adequate training, socialization or health care is strictly forbidden and will result in the Breeder seizing the dog to be placed elsewhere. This dog is to be a house pet and made a part of the family.

The Buyer agrees that the above-mentioned dog will be kept in optimum condition. This includes but is not restricted to coat and skin care, regular clipping of nails, proper weight control and the maintenance of overall good health. The Buyer agrees to follow the Breeder's suggestions concerning feeding, grooming and overall conditioning to the best of his/her abilities.

General

It is stipulated by and between the parties that failure to comply with this Agreement will result in the animal being returned to the Breeder due to lack of compliance by the Buyer herein. The Buyer shall forfeit all monies paid on the animal and shall sign over the CKC Registration papers to the Breeder immediately.

The Breeder is not responsible to pay for or reimburse the Buyer for any costs, expenses, claims, or damages of any nature whatsoever except as specifically provided in this Agreement.

The signatures below denote legal binding acceptance to the preceding Sale Agreement. No part of this Agreement is transferable. This Agreement contains the entire understanding of the parties with respect to the matters addressed herein, and any modification or amendment hereto must be made in writing and signed by both parties.
